

In 1917 and 1918, approximately 24 million men living in the United States completed a World War I draft registration card. These registration cards represent approximately 98% of the men under the age of 46. The total U.S. population in 1917-1918 was about 100 million individuals. In other words, close to 25% of the total population is represented in these records.

The WWI draft registration cards database can be an extremely useful resource because it covers a significant portion of the U.S. male population in the early twentieth-century. If you had family in the United States during WWI, you are likely to find at least one relative's information within this large collection. In addition, these cards contain more than just names and dates; they contain significant genealogical information such as birthplace, citizenship status, and information on the individual's nearest relative.

In general, the registration cards included the following information

Home address
Date and place of birth
Age, race, and country of citizenship
Occupation and employer
Physical description (hair and eye color, height, disabilities)

Using Land Records

The following article by Chuck Markum was originally printed in *The Outpost* Newsletter of the Three Forks Treasure Hunters Club, Volume XXII, Issue 5, July 2005. The information included in this article is very applicable to those looking for the old family homestead and cemetery, however, in addition to being able to find the map you need, you need to be able to read those maps. The township and range system used in Oklahoma takes a little getting used to. Since the original article was written for treasure hunters an explanation is called for here. Treasure Hunters use metal detectors to find metal (usually) objects. They are interested in history and are careful to not do any damage to the areas that they hunt. They do not hunt in cemeteries except to help identify where graves are located and in fact, many of them have been instrumental in helping to clear and restore Old Agency Cemetery in Muskogee County. A Little on Ownership Plats and Permission by Chuck Marcum

One of the hardest and sometimes the most time consuming task when you find a hunt spot is getting in touch with the land owner for permission to get on his property. To know who you are looking for helps a whole lot. Even if there's a house on the property a lot of times nobody is at home. When you have a name you can track them down. Just about every county has a Land Ownership Plat Map Book. With these maps you can tell who owns the property. Each book contains the whole county. Each page or plat has a whole township on it, 36 sections or 36 square miles. Each section shows the property breakdowns and names of the owners. On the bottom of the page is the copyright date. You want to get the most recent map you can. You'd be surprised how often property changes hands. You can get a copy of a page at an Abstract or Real Estate Office. Usually they'll make you a copy or two for free. I have been in quite a few Real Estate Offices where the person working there didn't know what I was asking for. After describing the plat books to them they'd look around and find one. Some Abstract Offices sell the books usually for about \$40.00. The trick is getting an up to date one. I know Delaware County just put out a new one in 2000. There's a few things you'll need to know to get the right plat. You'll have to know what county your site is in, the township number, range number, and what section you are

in. You can get all this information off of maps. Make sure to look at where you are on the plat when you get your copy. If there is a letter there instead of a name make sure you ask for a copy of that townships index which is in the book and will match the letter up with the name. They use the letters on smaller pieces of property where they can't fit the name.

Another place to get ownership maps is the County Courthouses. In fact the most up to date records are at the County Assessors Office. they know exactly who owns what piece of property since they are collecting the tax money. Every County Assessors Office is set up differently the only thing they have in common is that they all overcharge you for copies. 8.5x11 and legal size copies are \$1.00 each while Kinkos is about 3 cents each. Be careful getting oversize copies at court houses they're usually \$7 apiece. If you don't want to spend money on copy fees and your plats are out of date you can take the plat over to the Assessors Office, look at their up to date plat, and pencil in any changes. They can't charge you for looking at public records (not yet anyway). Like I've mentioned every county is different. Tulsa County Assessors have oversized plats which are divided into 1/4 sections which costs \$7.00 each or a whole section on the same size sheet for \$10.00. On both of these sheets they have account numbers instead of names. You then have to get on one of their computers, punch in the number to get the name and any other info you want. Remember you can look at the plat and the accounts in the computer for free. Rogers County has a web site. You can access their maps and accounts just by downloading a free viewer. The address is www.rogerscounty.org. Hopefully more counties will have sites like this in the future. Osage County also makes their own oversize plat maps. Some counties will have one section on 8.5x11 sheets. I believe Creek and Delaware Counties are like that. All counties have assessment rolls or accounts where you might find an address to the land owner which will help you find them. With a name and address you could find their phone number, but I'd use that as a last resort. It's a lot easier turning down somebody on the phone. Know the landowner's name when you know on their door. Take your maps to the door with you to show you've researched the site, and maybe even give them a copy of an aerial or old map of their place. If you have a good spot located take the time to research it and you'll probably get on it.

Turner stated to a Phoenix representative that the Turner Hardware Company would pave the East side of the street 249 feet north on Main from Broadway and that the K E. T. Company had agreed to pave their portion between the rails of the street care line's track.

It is understood the property owners on the west side of the street will take the matter up and probably pave the west side of the street also.

September 22, 1905

McCoy---Cunningham

On Tuesday our popular townsman, S. S. McCoy left for Muskogee taking with him Rev. J. A. Lowry, he went tither and came hither not however as he went, but with the flower of his heart, a partner to share his joys and sorrows. He was married, the lady of his choice being Miss Florence Cunningham, of Muskogee. S. S. has a host of friends his genial disposition winning at all time and they all rejoice with him in his new found happiness and the American is common with them wish that prosperity will be their for ever and aye.

Homer B. Spaulding

He was born 27 Feb 1862 in Lexington, TN and left at age 15 for Texas. Two years later he moved from Whitney to Sulphur Springs, TX. There he met and married Josephine, the daughter of S. B. Callahan of the Creek Nation.

Following his marriage in 1884, H. B. moved to Muskogee. The next year he went to work at the J. A. Patterson Mercantile Co. where he soon became a buyer for the company and later a manager.

About 1890 he left the company to go into business for himself. With \$2,000 of his savings, he purchased a ranch outside of Checotah on Cloud Creek that had been leased to the Patterson Mercantile Co. Within a few years, he is said to be grazing 20,000 head of cattle there.

About 1901 he reportedly drove the first automobile on Muskogee streets. Unfortunately, no documentation for this claim has been found. If true, this would mark him among the more progressive residents in Muskogee.

Spaulding was elected mayor of Muskogee in 1902. He

was the third person, but the fourth in office, to have served in this capacity. The following year he was elected the president of the Muskogee Commercial Club, the forerunner of the Muskogee Chamber of Commerce. He was its president for about four years.

About 1910 he built the steel Spaulding Bridge across the Arkansas River connecting Muskogee and Wagoner Counties. The piers of this bridge may yet be seen west of the US 69 Hwy bridge. The Spaulding Bridge was subsequently purchased and made into a toll-free public bridge.

Spaulding twice ran for the office of Sheriff in Muskogee County, but loss both times. He was a County Commissioner at the time of his death.

He was generous by nature throughout his life. One recipient was the First Methodist Church. Following the fire that burned the buildings of the Harrell Institute, his donations and fundraising resulted in the school being renamed the Spaulding College.

Homer B. Spaulding died 4 Sep 1918 and is buried in Greenhill Cemetery. Spaulding Park is named in his honor.



A Major Enhancement to the DAR Library

On the DAR Library's portion of the DAR's webpage (www.dar.org), one will find the continually growing index to our typescripts of genealogical information (Bible records, cemetery transcriptions, church records, etc.) that we call the Genealogical Records Committee Reports collectively. Our ongoing effort by DAR volunteers across the country, is creating this national every-name index to over 18,000 volumes added to our library since the 1910s. To date, the index contains over 18,000,000 names, and we are only about 1/4 of the way finished after 6 years of work!

Beginning today, when someone types in a name and the results are displayed, please note the following enhancements:

addition of the title of the book (in blue) in which the index reference appears,

and,

a red link for "More Information" that takes you to the cataloging record of the book itself. This latter link is most important to researchers because it will enable them/you to pinpoint the exact volume and shelf location of the book containing the information they seek. It also provides them with the subject tracings for the book to provide additional context for the indexed name. In addition, for those GRC Reports that have had the entire table of contents entered in note fields, these notes also appear in the linked record [There are some problems with the order in which the note fields appear, but we are aware of that.]

So, this is a huge advance in the amount of information provided by the GRC National Index. Now researchers (including many of you) will be able to focus in a bit further on the index references they find and use this information to determine if the reference is indeed one of importance to their research.

As a reminder: This index does not provide access to DAR membership applications or related materials. That is another animal completely and not available online.


Our cookbook has arrived! Get yours today!
