## HEZ HINS LOGATON FOR SUMMER CONCERTS

Approval of Plans for New Bandshell Is Cheerful News to Band Director

#### NEW SPONSORSHIP SEEK

Tony Goetz, Muskogee's talented hand director, is a happy man today because the WPA has allocated funds for erection of a new bandshell at Spaulding park. Tony is also puzzled because he now is wondering where the summer concerts will while the WPA workers are completing the new shell.

"We've got to have some place to play," he said. "It wouldn't be summer in Muskogee without our Thursday night concerts, and people already are phoning me to ask where we will play. I don't know,"

#### Needs Concert Sponsor

The first of a series of summer concerts directed by Guetz is scheduled for June 2.

What he needs now, Goetz figured yesterday, is someone to sponsor his concerts.

"If I can find someone willing to undertake the job," he said, "It might be possible to build a temporary bandstand on a vacant lot adjucent to

Hotel Severs on West Broadway. "Anyway." he said, "we'll find a place and our concerts will begin on

tlme."

The work is scheduled to be completed by July 1, but an extension of time probably will be granted.

Goetz was enthusiastic about the proposed new bandshell, assured yesterday when the WPA allocated \$20,-596 to Muskogee for continued improvements in Spaulding park., "It's wonderful," he declared. "It's

something we have needed for several years, and we are extremely happy that it is about to be realized."
Old Band Shell Razed

Additional allocations announced yesterday by Ron Stephens, state WPA administrator, also will provide for bathhouses at Spaulding park, and supplements \$44,000 already allocated to begin construction of a awimming pool there. Work was begun on the pool March 23.

Original plans called for a swimming pool, bathhouse, bandshell, concession stand, filtering and treating plant, and six double tennis courts. It was necessary, however, to temporarily delay starting work on the bandshell and bathhouse until another appropriation was made,

Tennis courts were built in Spaulding park, Turner hill, Honor Heights and at Twenty-fourth street and

Arline avenue.

The original approval also included the \$11,000 Towar hill project.





#### TO DEDICATE HIGH SCHOOL

Muskogee Times-Democrat, November 11, 1910, page twelve:

The Muskogee Board of Education has announced that the formal dedication of the new Central High School building will take place on the evening of Monday, November 28. Dr. Nathaniel Butler, professor of education in the University of Chicago, has consented to make the dedicatory address and there will be other talks and features of the program that will be of great interest. Dr. Butler is one of the best known educators of the United States and his addresses are famous everywhere.

There will be music by the classes of the school on the dedication night and the faculty and board of education will personally have charge of the program. Every patron of the high school and friends of education generally are invited. Besides taking part in the dedication program, Dr. Butler will examine the school and its equipment with the view of placing the Central High School on the list of institutes co-operating with the University of Chicago. If this step is taken, graduates of the local High School will be admitted to the university without examination and will undoubtedly be favored with several one-year scholarships in the institution, forty of which are annually awarded to the most promising graduates of all the co-operating schools.

Present at the meeting were J.N. Wilkinson, of Muskogee, Chairman; E.B. Shotwell, Okmulgee; B.H. Hester, Claremore; J.F. Gambill, Muskogee, and E.S. Monroe, superintendent of city schools.

The program when completed will be one of the best ever rendered at a teacher's meeting in Oklahoma. E.S. Monroe and W.T. Hefley of Muskogee are speakers on the program, and J.F. Gambill of this city, who is President of the association, will of course deliver the President's Address.

Muskogee Times-Democrat, Friday, February 14, 1908, page two:

#### TOWNSHIPS ARE GIVEN NAMES

Late Wednesday afternoon the county commissioners formally ratified the selection of names for the various townships of Muskogee County, so that hereafter, each one of the fourteen townships will be known by names instead of by numbers.

The county is to be congratulated on the fact that the commissioners have seen fit to honor many of the old settlers by the use of their names in this matter. Practically every township will bear the name of some old pioneer family, Indian or white.

Township No. 1; to be known as "Moore," is named after Judge Moore of Haskell;

Township No. 2; named "Agency," is so called after Agency Hill, formerly the residence place of the agent to the Five Civilized Tribes;

Township No. 3; named Harris, is so called after one of the oldest Cherokee families, County Commissioner W.H. Harris being of the family;

Township No. 4; will be known as "Porter" in honor and remembrance of Chief Pleasant Porter of the Creek Nation.

Township No. 5; named "Nash" after F.H. Nash of Fort Gibson, one of the pioneers of the Indian Territory.

Township No. 6; named after the noted Brewer family;

Township No. 7; Ogle, is so named in honor of J.H. Ogle of Boynton, the oldest settler there.

Township No. 8; named Sutton, is most appropriately named after County Commissioner T.B. Sutton, the only Republican elected to a county office in Muskogee County.

Township No. 9; to be called "Brown" after G.C. Brown, the oldest settler in the district.

Township No. 10; known as "Darling" after a prominent banker of Oktaha;

Township No. 11; will be known as "McLain," after one of the oldest families in the Cherokee Nation.

Township No. 12; will be known as "Vann" after a well known Cherokee family which County Commissioner Charles E. Vann is a member.

Township No. 13 is to be known as "Martin," after J.A. Martin, the oldest man in the township.

Township No. 14, will be known as "Porum," after the famous Porum Gap, one of the oldest landmarks in the west.



#### WILL ARREST MEN WHO BLOCK STREET

Katy Switchmen Who Tie up Traffic at Fondulac Crossing to Face Police Judge.

:

Switching crews who continue to block the Fondulac Street crossing for an unreasonable length of time will be arrested. City Manager Harrison issued orders Saturday to Chief of Police R.L. McAfee to arrest any switchman who were responsible for long lines of autos and pedestrians held up at the crossing.

With the viaduct over the Katy tracks closed because of the bad condition of the floor, and with Broadway and Okmulgee torn up near the tracks, the use of the Fondulac Street crossing has become more general in the past few months.

Autoists and others have complained to the city manager that they were held up as long as half-anhour by trains which were not moving. The trains should be split.

"We have warned the Katy officials and switchmen several times," said Mr. Harrison. "Now we will begin to make arrests, if they don't become more reasonable about it. The streets must be kept open at all times except when trains are actually passing."
