LETTER FROM THE PRESIDENT


Choska, according to the 1905 Gazetteer of Indian Territory, was a post village in the Creek Nation. Choska, however, was always recognized as an early trading area along the Arkansas River since the 1830's. It's rich bottom lands afforded the Creeks bountiful crops.

The 1890 Muskogee Weekly Phoenix mentioned Choska as having "1000 souls and is the second city in the Creek Nation...this is a great pleasure resort where deer and turkey abound, and for chicken (prairie) hunting there is none like it."

Though Choska is placed in Wagoner County, it is included here because so many of its inhabitants were Muskogee-connected, both by trade and families.

T.F. Meagher, wealthy Choska and Muskogee cattleman and farmer, drew the map of Choska bottoms.

The Sand Hill Cemetery, which lies in the hills east of the bottoms is where many of it's inhabitants "rest in peace." This is an old cemetery with hundreds buried within, but many with no written tombstone.

We have listed 44 more tombstones; with the last burial there being in 1968.

Some of our dates and names did not match up with Tyner's listing, but this is typical of cemetery readings. PLEASE read the following article about the unreliability of cemetery readings!

BEWARE: THE WRITTEN WORD

I am involved in the recording of cemeteries and transcribing the readings of other individuals. It is quite an education to prepare these readings for publication so that interested people may discover the location, birth and death dates of their ancestors.

This experience has opened my eyes to the fact that cemetery readings may not always be trusted. They are excellent sources to consult, but should be investigated further.

Examples of misinformation might come from the stone itself. An incorrect surname, initial, or dates may have been given to the stone carver. A stone may be so deteriorated that exact dates may not be readable. In some cases you may find that two names are on a stone, obviously husband and wife. One may not have a date of death. It could be that one party is not yet deceased, or in some cases, one party may have remarried and is buried beside a second spouse.

A common mistake is sometimes made in transcribing the final record from another person's handwriting, your own handwriting, or a simple typographical error. Recently, just one of my typing errors, which was caught in proof reading, was that I promoted one of the deceased from a <u>Cpl.</u> to a <u>Cpt.</u> I'm sure he would have been pleased.

Another example of error is that one recorder listed a name as "Reed" and another transcribed the same stone as "Reeves". For one searching for his surname, these two are far apart.

Stones may be missed during a reading, and in the very old cemeteries, the markers are missing, or are just beyond reading.

Cemetery records are invaluable and organizations are realizing how important it is to preserve the information in them. They are not infallible. Use them as a tool to further investigate the validity of a birth or death. You have a starting point which may lead you to a primary source.

The following article appeared in the 16 Mar. 1986 edition of the Columbus Dispatch and was written by Jim McGavran. We thought it had a lot of merit so have re-printed it here.

It seems that when I am not worrying about one thing I am worrying about another. I can't help it.

Right now I lie awake worrying about the future of genealogy. The way we are carrying on, no one will be able to find his or her roots a hundred years from now.

They might not be able to find me.

I think that's too bad. Genealogy is a hobby that everyone can enjoy. It is fun, and it doesn't cost a lot of money or require special equipment, such as golf and skiing do. It beats collecting things, such as salt and pepper shakers which have to be kept dusted.

Up until now, it has been fairly simple. All you had to do was check old census records or hunt for wills, deeds, marriages, and births. Or you could spend a

pleasant vacation tramping through old graveyards.

ALL THIS is changing. Old cemeteries won't help if people choose cremation over burial. Where will you look for information about an ancestor whose ashes where scattered over the Pacific Ocean?

Census records are becoming worthless. People don't stay in one place more than a year or two, let alone from one census to the next.

Forget the courthouse too. Why look for an ancestors' will if he or she bought

a book on how to avoid probate and succeeded in doing so?

Current lifestyles render courthouse records obsolete. What will be the point of looking for birth or marriage records if ones' great-grandmother insisted on having all her children out of wedlock? What if she did get married but kept her maiden name? Or suppose she had children by three legal husbands so that all her offspring had different last names?

I can envision someone searching for roots in the year 2086. I see this individual entering the Bureau of Vital Statistics, approaching the computer and pushing the "on" button.

"May I help you?" the screen will respond.

"I am looking for my grandfather's birth certificate," the latter-day genealogist asks, one letter at a time.

"Name please?"

"Harley Solo. Mother, Mary Solo. He was born 4 April 1992."

Lights flast, clicking and humming noises are heard as the computer conducts its search. A green light appears on the screen.

"Mary Solo gave birth on 4 April 1992. The rest is classified. Please consult headquarters."

The future genealogist goes to headquarters and weeks later returns with the access code. He punches it in. More lights flash. Bells ring. This time the computer has the decency to blush.

"Mary Solo, spinster, was impregnated with material from a sperm bank. Donor's name unknown. Hair and eyes brown. Medium height and build. Tendency to early baldness. No congential deformities. Said to be musical."

And there goes someone's search for roots. I know it's silly of me to worry about it, but it's things such as that which keep me awake nights.

What are we doing to our future genealogists, our own descendants?

LETTERS TO MA

The following excerpts are taken from the original letters written by my great-grandparents in 1899-1901 in Indian Territory. "Ma", or Mary Elizabeth (Christian) Agee, from her son and daughter-in-law, Thomas Joshua Agee and Ella (Martin/Martain) Agee. T.J. Agee moved his wife and four sons to Webbers Falls in late July 1899.

Dear Ma,

Webbers Falls, I.T. Sept. 4th 1899

I guess you will be a little surprised to get a letter from us at this point. We landed here last Tuesday Aug 29th left Maguire Monday stayed at Bell's (Belle [Agee] Reagan) Monday night. Tom commenced work in Mr. Hayes Drug Store Sept. 1st. We now have rooms upstairs but will not stay any longer than we can get a house. There is not a vacant house here now business is lively. I think we are going to like to live here splendid. We did not ship near all of our things just what we thought we could get along with. We intend to have the rest shipped after while. We sold our hogs and our calf and chickens. We left Daisy at Edgar Williams in pasture. He is going to milk and take care of her. We did not know rather you would like for us have her brought down here. As you still claimed her. I was very sorry to leave her and we miss her so much. But however she is at your disposal and Edgar understands that she is yours and will give her up at any time. We left our things with Joe Wrights folks. I washed a big washing today. Glen is going to try cotton picking. School begins here Sept. 11th. Joe Oliver came with us. Mrs. Williams was very low when we left. Ma write me as soon as you get this I will send you a paper from here and write you about the town next time. We did not know were were coming in time to write you and get our answers before we started.

Dear Ma,

Your letter rec'd was good to hear from you we had looked and looked for a letter while you was in Mo. We came here right into the measles. We thought perhaps we could escape but no such good luck for us. Four weeks ago today Ernest broke out. He was very bad we thought for several days he would not get well. But he has got up and looks well but he is bloated. In a little over a week Glenn broke out. He was real sick but we did not have to have a Dr. for him. He improved fast after he got up. A week ago last Tuesday Leslie broke out. He was very sick also had a Dr. for him. He is better but improving very slow not able to sit up any. He is very thin and weak but is beginning to eat a little. We think he is out of danger but the bowels have been the trouble in all the cases which proved fatal and he has had that trouble. The Baby is well and just as fat as he can be. Don't look as though he is going to take it at all. We moved four weeks ago have a nice location a short distance from the business part of town. We did not get that parsonage. We have a 4 room house. Two upstairs and two down. A big barn smoke house wood and coal house a fenced chicken yard a big garden pig pens lot for all kinds of stock a nice big yard. Also a pump and cistern. We have to pay $\$8\frac{1}{2}$ per mo and now use for any other improvements, but houses are so hard to get that we had to take it. One of Jim Olivers children died with measles and two more that are about to die. Joe and Bula have gone back to Maguire. We have never sent for our things yet. Would have sent long ago if all had been well. I think we will send now soon. The children all wanted to go back when they were sick. But I think they will get satisfied. Ernest cried for us to send for his Aunt Belle to come and get him when he was so sick we thought he could not possibly get well. We have to burn coal here. We bought a stove today and put it up. Have a fire tonight. Use wood for cooking. The neighbors have been very good to me since I moved here. We live in one of the very best neighborhoods in town. I left my carpet rags there where we lived. Joe Wright's folks live in the house and after we send for our furniture we left the rags will be the most important thing there. I don't know what to have done with china only I want them taken care of but I will not need a carpet until next summer anyway. There is a good many Arkansas people here. I have not seen any of them but Tom has. Dave Dickey, Blackwells, and Jus. Towler. Yes and he saw Bugar Reynolds. He does not live here just passing through. I buy a pint of sweet milk a day do without butter we cannot get it. I cannot think of anything else to write now so will close write us soon.

Dear Grandma,

We got your letter today and was glad to hear from you there was 42 loads of cotton come in yesterday it is a nice place. There is two churches here, a Methodist and Babtist meeting at both churches. Union Sunday School at the Babtist. They have a big wind pump here. Papa gets \$30 dollars a month.

We had a big mess of fish out of the arkansas river. we can see the river

from our window it runs along the east side of town.

There is more business here than any place that I ever saw and I don't know how many business houses ther is. Grandma we got shed of the dogs, cats, Guns and Birds when we left arkansas and we left Daisy and miss her most of all. I want to try to work some and go to school.

Dear Ma,

....I was surprised to hear of so much sickness in Fayetteville. There is a great deal here mostly measles. There has been a great number of deaths from measles a Mrs. Hayes died this eve. Her Baby a month old died Thanksgiving. John Hampton's wife was dying last account late this eve. She is Lewis Olivers daughter. The children all go to Sunday School. The people all treat them so nice they like to go. I have a neighbor Mrs. Dr. Darnele that is well acquainted with the Agee family at Camden Ark. She lived neighbor to them before coming here two years ago. If we just keep well I will never regret coming here. I never have been so well satisfied. There is just as good people here as any where. ...

Dear Ma,

....We have rented the "Pollard Hotel" will take charge the 1st of March. It is the leading house here a nice location. Tom's place of business will be just across the street from Hotel. I have been busy sewing this week. I ironed today. Tom will write when he can. He is so busy he don't have time for anything. Sunday or any other day. He so seldom gets to come at meal times that he most always has to eat by himself...

Dear Ma,

Mar 11th 1900

...I am not liking the Hotel business. I hire my cooking and washing done. I try to do the rest myself but I find it is more than I can do. I have 7 regular boarders a good many drummers for dinner not many to stay overnight. I am thinking about giving it up and move to a place and make a garden. It is too cramped a position to suit me....

Dear Ma,

As Tom has not wrote you for some time I will write tonight. I have been very sick. Am able to be up now and cook a little is all I can do. I have a very hard chill Sunday three weeks ago and Monday I had a congestive chill then had fever nine days and was very sick had to be set up with all the time. The neighbors was very kind and good. They had a time with the baby but we did not wean him. I think I will soon be strong enough to do all my work again. Glenn had a chill today. It looks like we can't keep them from chilling and we give medicine nearly all the time. Tom wants me to take the children and go to Ark. and stay this summer when I was sick I thought as soon as I was able I would. He wants me to go out in the country about Maguire and get a room or two and get the cow and keep house which I could do without much expense.... I don't want to go and leave him here.

Dec 30th 1900

....Sorry Mas's health is so bad I wish she could come to see us.... We had a nice tree at the K of P Hall. We send you a paper which will tell you all about it. We were invited out to dinner Christmas day to Mr. and Mrs. Colesmans. He is in the grocery business here. We were also invited to dine Thanksgiving at Mr. and Mrs. Reeds. Both dinners we enjoyed very much. We lived next door neighbor to Reeds last winter. His first wife was a neice of Mr. Mose Lewis. He is now living with his second wife.Our Daisy cow is just doing fine. I have all the butter and milk we can use and some to sell. Butter is 25 cts per lb. We have a nice sow and seven pigs. Had a big hog killed last Wed. So I have plenty of fresh lard and sausage....



RED BIRD HARRIS

Red Bird Harris, son of William Harris, a white man, and Susan Collins, daughter of Parker Collins, a half Cherokee; was born July 1839 near Alanta, Georgia.

In 1858, at age nineteen, he came out to Indian Territory by steamboat. He settled some land in the Cherokee Nation just above the bottom lands of the Arkansas River. On this land was an old Indian mound used as a lookout. It was this site that he made available to the Confederates to build Fort Davis, himself a loyal confederate soldier. He later was a member of the G.A.R.

Red Bird married Sarah Ellen Rogers, daughter of Dr. Robert Rogers. She taught school at the old Tullahassee Mission.

Red Bird's brothers and sisters: Emily Harris, James S. Harris, Joseph B.N, William G., Charles, Parker Collins (1845-1920), Eliz. Jane Savannah Harris, Philo (1848-1933), John, and Johnson Harris (b. 1856). Johnson Harris became Cherokee Principal Chief at the death of Joel Mayes in 1891. Most of Red Bird's family resided at Brushy Mountain and are buried at the Brushy Mt. Cemetery.

Red Bird's son, Cheasquah Bird Harris, helped build the Harris-Jobe School in 1906, which is still being used and added on-to today.
