(Editor's note: The following is a portion of a larger article, but is copied exactly as it appeared in the Muskogee Phoenix Newspaper)

"The Company is the only representative from the Indian Territory and is composed of a set of men hard to beat. They are all gentlemanly in their behavior and greet visitors courteously. They are quite a number of genuine Indians among the company and are much sought after by lady visitors, who through curiosity, are anxious to look upon and converse with a real life warrior."

"They were recruited 'for a period of two years unless sooner discharged by the proper authorities'. They took the same oath as the other recruits."

CONFEDERATE MONUMENT

The corner stone of the confederate monument that is to mark the final resting place of the 440 unknown confederate dead buried in the cemetery at Van Buren, Arkansas, was laid on the 24th. Arkansas, Missouri, Texas, Louisiana, and **The Indian Territory** were represented. Fully 50% of those interned at the place are Missoureans.

Judge THOMAS (Muskogee?) is the proud possessor of a handsome gold cane presented to him by Joe KLINE and Tom ISBELL, two members of the ROUGH RIDERS who made themselves famous at the battle of El Caney. Judge THOMAS is quite proud of the gift and prizes it highly.

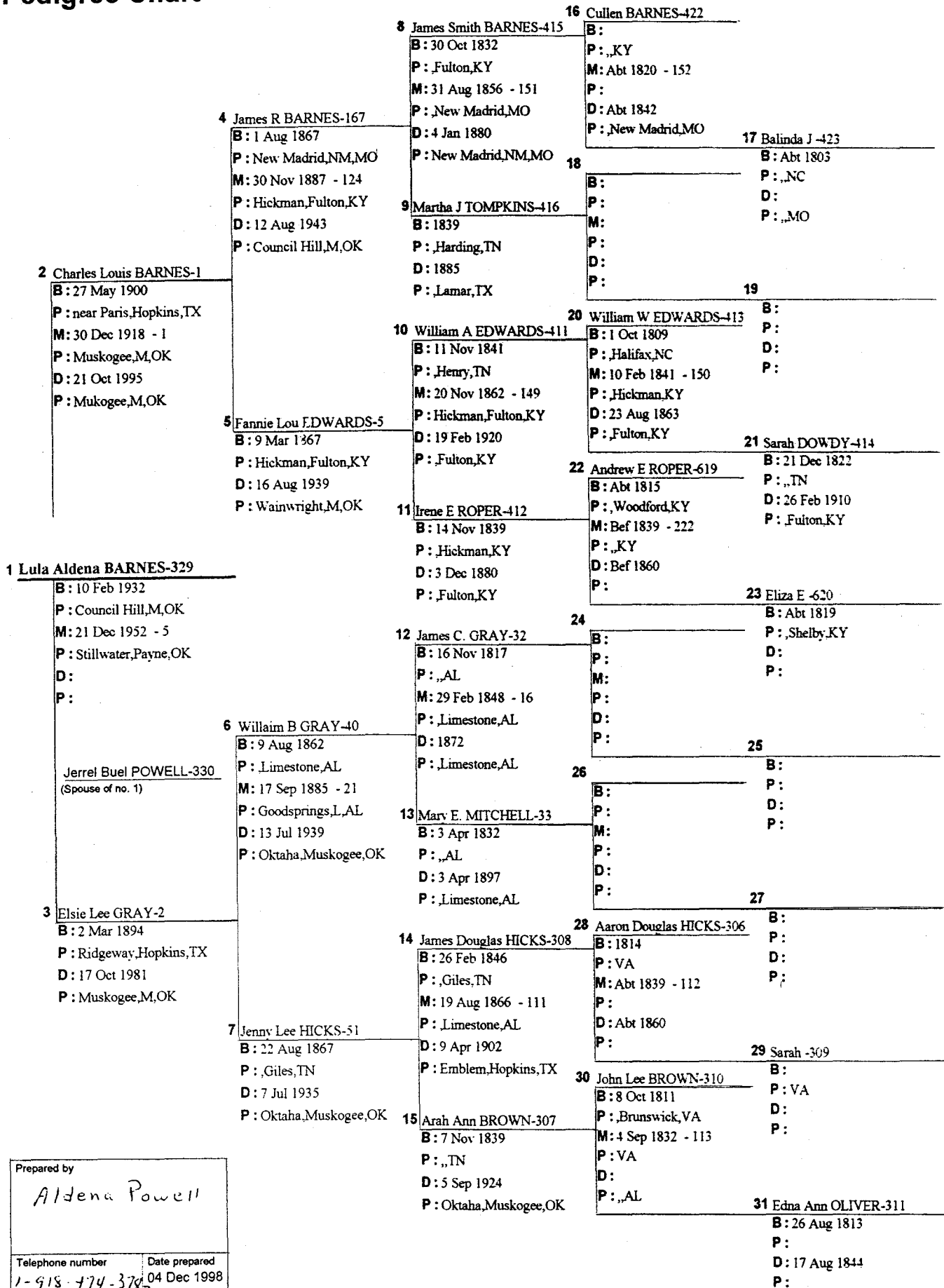

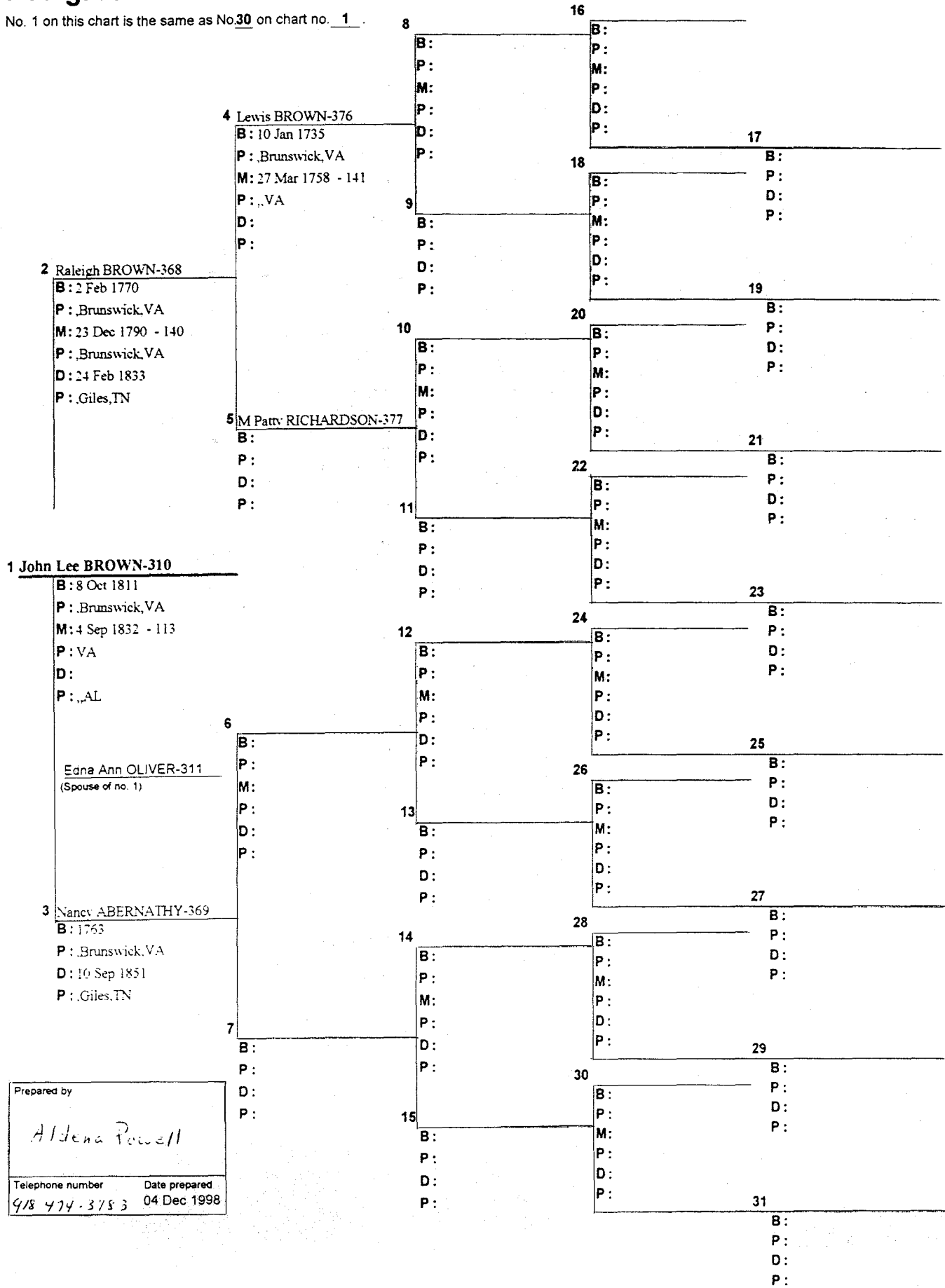

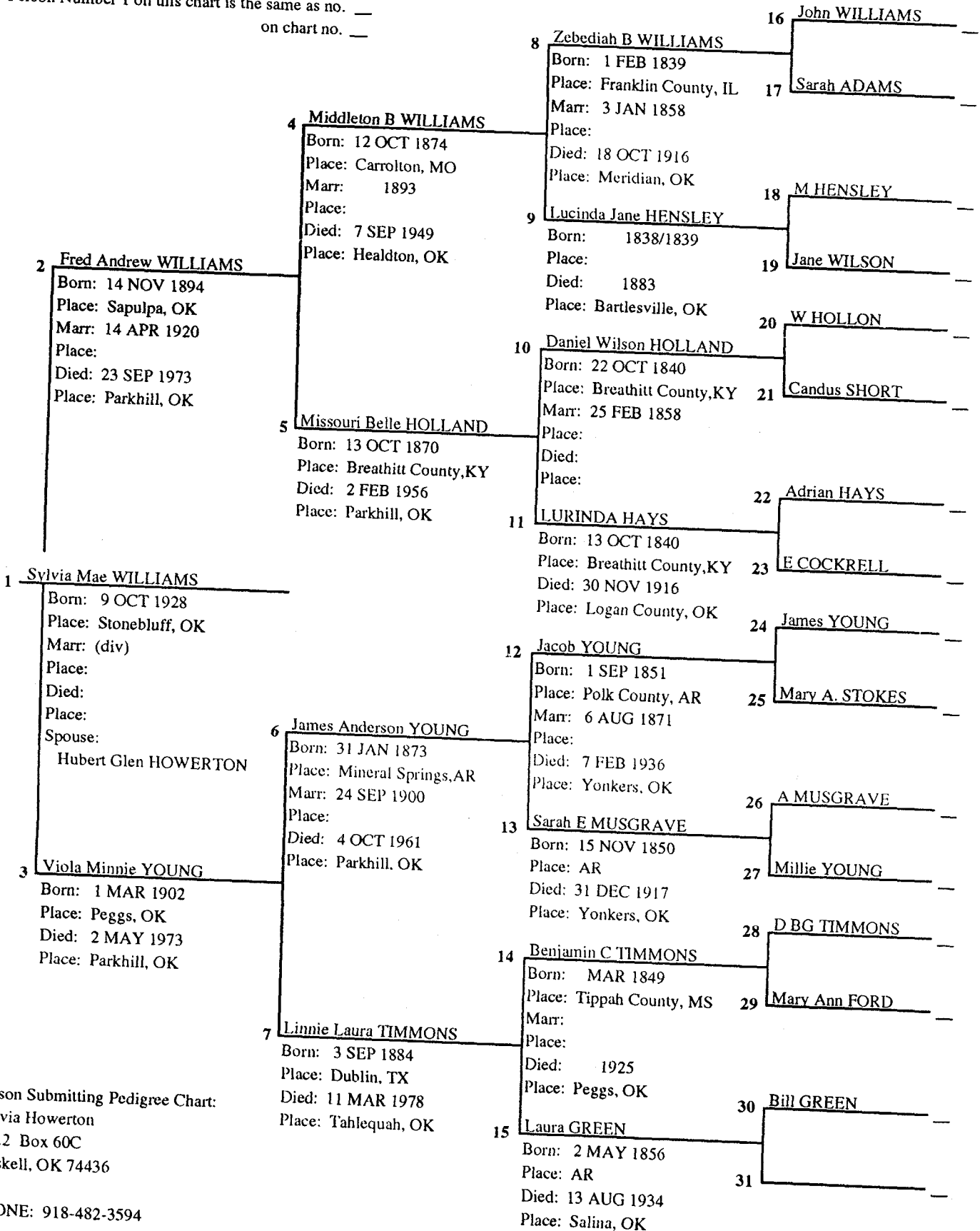
Pedigree Chart of Sylvia Howerton

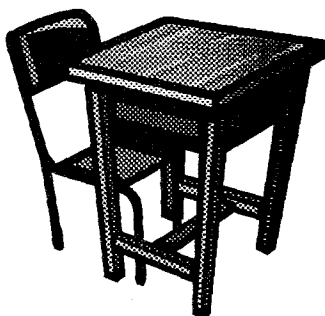
