

### Internet Genealogy: A Viewpoint

Wally Waits contributed the following email message that he found posted on one of the Internet Genealogy discussion groups.

"... I think that the role of the Internet is still in an early stage of evolution, and much remains to be sorted out. Regarding patron behavior, I think what hasn't happened yet is the development of a large of number of researchers blending virtual and physical research. You have a large number of researchers, with resources close at hand, which haven't developed a great enough need for remote databases to warrant their learning new technology. On the other end, you have an increasing number of researchers, many of them newbies, who have used the Internet as the core database of their research in lieu of more traditional, direct sources.

One has to differentiate between different functions of the Internet as they influence research...

- 1) The communications aspect is really still paramount, as bulletin boards and chat rooms provide key functions of query exchange, idea discussion, and social validation that the network of societies, their newsletters and other research organizations has long provided. In fact, I think it could be argued that one outcome of the Internet's development will be that genealogical societies may need to rethink some of the core parts of their missions.
- 2) The database aspect is complex and will not necessarily be linear in its development. That the development of electronic genealogical content has occurred in parallel to the commercialization of genealogy cannot be overstated. While altruism still resides in some quarters as researchers recall their original research motive, i.e., to freely share the fruits of their work, the siren call of profit whines ever more loudly. As in other fields, various attempts to extract revenues from research, whether with teasers (indexes only online), subscriptions, or other devices, can provide enhanced remote access, but at a price which makes that access less economical for local patrons who also have print resources available to them. For libraries, pressures by Internet content providers to generate revenue in tandem with information distribution poses a challenge, because libraries' structure of information sharing is at odds not only with the pay-forplay and other service models, but the control over information that Internet providers are also trying to impose. Our experience generally with Internet content providers is that their pricing structure is at least several multiples more expensive than warranted, considering the frequency of use those services would get in our library, and for a service that, while providing some convenience, also brings additional headaches (e.g., additional patron training, cumbersome software, annoying copyright restrictions). This maybe works for the largest libraries, but not for us. We have also been loath to get on the CD-ROM database bandwagon, as CD-ROMs are a submerging technology, and the quality of much work out there (e.g., IMHO, much FTM stuff) is still GIGO. However, it will likely make sense to employ CD-ROMs in particular situations, such as census indices, the Germans to America series, etc. where the benefits of 1) space saving for 2) works whose provenance and value are either a given (e.g., U.S. Census) or already well established (e.g., Germans to America) at 3) a lower price than print (provided you already have the hardware) make up for headaches you take on.

It is very likely that the generational gap between computer-comfortable novice searchers and more-experienced but less Net-savvy researchers will narrow, though never completely. A parallel might be drawn with the popularity of genealogical software, which in the mid-1980s might have been predicted, but not to the degree we see today."

The Muskogee County Genealogical Society Board of Directors hosted a Special Planning Meeting for all interested MCGS members on Thursday evening September 7th from 6:30 – 9:00pm in the home of Deone Penquite. The purpose of this casual get-together was to talk about what we can do to make our Society more rewarding for our members and guests. To ensure that we came out of this meeting with clear and understandable action items, we covered only two topics and those results are shown below:

#### **HOW TO IMPROVE MONTHLY MEETINGS:**

1. Form a committee to select topics and speakers for meetings.

Suggestions: select an annual theme, divide volunteers into sub-committees to report on various states' research and to have a Spring Beginners' Workshop

- 4. Have permanent name tags available at each meeting. Name tags might include names of families being researched.

5. <u>Greeter at each meeting to greet guests and new members</u>. Greeter should introduce them, help them get refreshments, etc. It was suggested that the president select greeters for each meeting.

6. <u>Prepare a society pamphlet / brochure to give to new members, guests, etc.</u>
This could include ideas for research and list some things that are available at the Muskogee Public Library.

- Be sure meeting topics appeal to all levels of researchers.
- Have a specified time at the end of meetings for visitation and research assistance.

- Keep the business portion of meetings short.
- Have minutes of past meetings printed and distributed instead of read.
- Give complimentary quarterlies to guests and new members.
- Ask members for topic ideas at each meeting.
- Print and distribute member appreciation certificates.
- Alternate meetings to have a speaker one time with research opportunities the next.
- Be sure speakers are aware of time limits.

## Item: HOW TO MAKE GUESTS FEEL MORE WELCOME SUCH THAT THEY WILL WANT TO BECOME ACTIVE AND PARTICIPATING MEMBERS.

Greeter should introduce them, help them get refreshments, etc. It was suggested that the President select greeters for each meeting.

#### CONFEDERATE VETERAN'S REUNIONS

For many years after the end of the Civil War, the United Confederate Veterans had conventions in Southern cities. Two young ladies living in Oklahoma with ties to Wentworth, Rockingham County, North Carolina, were honored with appointments as convention hostesses at different times.

Miss Carrie Hancock (1891-1996), was the daughter of John Wesley and Hattie Hancock and granddaughter of Civil War officer Col. Ezekiel Wheeler Hancock, all of Rockingham County. She was a senior in high school in Muskogee, Oklahoma in May 1911 when chosen to represent the state at the United Confederate Veteran's National reunion in Little Rock, Arkansas. Some 5,000 veterans and their families attended the gathering from Oklahoma. A total of 12,000 Confederate Veterans were in attendance at this 21<sup>st</sup> annual reunion. Carrie was living in Muskogee with her father's brother, Numa Fletcher Hancock and his family. Numa and Virginia Hancock also attended the convention with their niece. Numa F. Hancock, born in Wentworth, was a well-respected pharmacist and a member of the Confederate Association in Muskogee, having lived in this Indian Territory town since 1893.

Miss Virginia Hancock (1898-1980), daughter of Numa and Virginia Hancock, of Muskogee, Oklahoma, Carrie's cousin, was chosen as a maid of honor for Oklahoma when the Confederate Veterans had their reunion in Tulsa, Oklahoma, in September 1918. At that time, Virginia was a student at Oklahoma University.

The Civil War had ended 53 years earlier and tens of thousands of Confederate soldiers, their descendants, and other Southerners were expected to attend. The city of Tulsa, incorporated 21 years earlier, had a population of about 70,000 and was taxed to handle the crowds and had asked for private homes to take in visitors. A new convention hall and theater had been built four years previously and the main streets were paved. A veteran who was 25 at the end of the war would have been 78 at this time. The local newspaper on September 25, 1918 had an interesting story about Boy Scouts and the aid that they gave to the visitors.

#### TULSA'S BOY SCOUTS

The boy scouts of Tulsa are playing a very large part in making the confederate veteran's reunion a success, and in creating a favorable impression upon our visitors. These manly little fellows are everywhere; they are as busy as any of the committees and they are on the job all the time.

They meet the trains and help the veterans find the places assigned to them, and if necessary, they do not hesitate to commandeer a passing automobile, load it with visitors and order the driver to take his load to the various parts of town where the visitors are to stay.

You can find them on the crowded corners ever watching for a chance to help some feeble veteran safely across the street, or to give him information.

They also render valuable assistance to the traffic police in keeping the

crowds and autos moving and in preventing accidents.

One of the things our visitors are going to talk about when they return to their homes is the polite attention and efficient work of Tulsa's boy scouts.

Carrie Hancock married Charles R. Born in 1923 and resided in Enid, Oklahoma. Virginia Hancock was married in 1926 to Allen K. Owen of Winston-Salem, North Carolina where they resided.



#### **NUMA FLETCHER HANCOCK**

Numa Fletcher Hancock, born April 11, 1859, was the sixth of twelve children born to Ezekiel Wheeler Hancock and Mary Magdaline (Allen) Hancock. He was born on the family farm in Wentworth Township, Rockingham County, North Carolina, and named for the popular Rockingham County Methodist Minister, Numa Fletcher Reid.

Numa was educated in the Wentworth school and served as the Postmaster of Wentworth July 1885 until February 2, 1887. At that time he began working as a drug clerk in a Reidsville, Rockingham County, drug store owned by F. M. Matthews and Co. Numa and his brother William Pinkney Hancock became proprietors of a Wentworth hotel as shown in the 1890 Business Directory of Rockingham County, NC.

In the next few years, Numa Hancock studied to be a druggist in North Carolina, worked in a drug store in Little Rock, Arkansas, and in Muskogee, Indian Territory, now Oklahoma. He returned to Winston, NC, to marry Virginia Alma Stafford. They were married November 14, 1895 in Winston, Forsyth County, NC. in the Evangelical Lutheran Church by Rev. W. A. Litz. Virginia "Virgie" Stafford was born in Winston January 15, 1859, the daughter of A. J. and Cornelia Stafford (1828-1901). Cornelia was born in Prince Edward County, Virginia.

Numa brought his bride and her mother to the Indian Territory town of Pryor Creek. Before long they moved to the Creek Indian Nation town of "Muscogee" where only 20 years earlier the town was described as having a single street of shanties, open to the wind which blew like a hurricane. The majority of the citizens were Negroes, formerly slaves to Indians, deep in poverty and ignorance.

He was a prescription clerk at the Palace Drug in Muskogee until he became the owner of his own drug store, the Muskogee City Drug. By 1906 the Hancock family had built a large, two story home at 504 Denison that was still standing in the late 1980's when it was torn down to make way for a shopping center. The house was always in Virginia Hancock's name. She took in boarders to help with expenses.

They helped to educate a Hancock nephew and two nieces, all from Rockingham Co., NC. Claude Mitchell, son of Dora Hancock Mitchell; Ellen Burton, daughter of Harriet Wilmoth Hancock Burton; and Caroline Hancock, daughter of John Wesley Hancock. They all lived in Muskogee with the family. Claude stayed for a very short time. Ellen attended the Catholic School, and Caroline who arrived in 1906 and stayed until January 1923 when she was married in the Hancock home to Charles R. Born of Enid, Oklahoma.

Numa and Virgie made many trips back to NC where his brothers and sisters looked forward to these visits. He was well respected by his family in NC, as well as the residents of Muskogee. Numa was elected a Muskogee County Commissioner in 1902 and appointed an Oklahoma State Drug Inspector July 20, 1915. He was a life long Methodist and a Sunday school teacher in the Wentworth Methodist Church in North Carolina. A charter member of St. Paul's Methodist Church in Muskogee where he also taught a Sunday school class. Numa was also a 32<sup>nd</sup> degree Mason and past commander of the Masonic Lodge, a Shriner and a member of the Woodsmen of the World.

Hancock Street, an East-West street south of the City of Muskogee, was named in honor of Numa F. Hancock as an outstanding citizen and for his contribution to the growth of Muskogee.

Numa Fletcher Hancock died September 6, 1938 in a Vinita, Oklahoma hospital. After funeral services at St. Paul's Methodist church, Numa was buried in Greenhill Cemetery, Muskogee, in lot A, block 69. Virgie Stafford Hancock moved to Winston-Salem, NC, to be near her daughter, and died there March 6, 1943. She was returned to Muskogee to be buried next to her husband, son, and mother, Cornelia Stafford, who died November 8, 1901 after a fall in her Muskogee home.

The children of Numa Fletcher and Virginia Stafford Hancock:

 Virginia Hancock, born January 11, 1898, in Muskogee, IT. She married April 12, 1926 in Muskogee to Allan Kent Owen of Winston-Salem, NC. She died May 22, 1980 in Winston-Salem, NC, where she was buried in the Moravian Cemetery.

 Allen Hancock, born February 15, 1900, in Muskogee, IT. He died July 13, 1904 of the "flux" and was buried in the family plot in Greenhill Cemetery, Muskogee, Oklahoma.

#### THANKS BETTY:

"Cherokee Indian Rolls Doubtful and Rejected" was transcribed by Betty Taylor Harris about a year ago. The popularity of this book has been tremendous and the sales have been excellent. Along with private sales, this book has been placed in some of the largest libraries in the United States.

Betty spent the better part of a year transcribing, from film, information for this book which consists of 263 pages. It is an alphabetical listing of Cherokee names classified as "Doubtful" and "Rejected" by the Dawes Commission. The person's sex is followed by a "D" or "R", the code for the Doubtful and Rejected series followed by their card number.

The 14x17 cards are annotated with information for each applicant, such as post office address, previous tribal enrollments, relationship to the head of the family, degree of blood, names of parents, references to related enrollment cards, and actions taken.

The Dawes Commission began the enrollment of Cherokees under the Curtis Act of 1898. Under the August 7, 1902 agreement with the Cherokee Tribe, eligibility for enrollment was restricted to persons who were born prior to children living on March 4, 1906, whose parents were enrolled or had applications pending.

These cards are on microfilm at the National Archives-Southwest Region at Fort Worth or at the Muskogee Public Library, Muskogee, OK.

The society appreciates the dedication to the preservation of records as shown by Betty Taylor Harris and to others who have spent countless hours in transcribing material for the books that are published by the Muskogee County Genealogical Society.
